GEC RISK is committed to protecting your privacy. This Statement of Privacy applies to the GEC RISK Web site and governs data collection and usage. By using the GEC RISK website, you consent to the data practices described in this statement.

Collection of your Personal Information

GEC RISK collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. GEC RISK may also collect anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by GEC RISK.
